

## **POLICY FOR THE PROCESSING OF PERSONAL DATA PURSUANT TO ART.13 OF EUROPEAN REGULATION NO. 679/2016**

### **1. DATA CONTROLLER:**

Eurotextilati Spa, with registered office in Dro (TN), loc. Pietramurata, via Collungo 14. Email contact: info@eurotextilati.com.

### **2. DATA PROCESSED**

During the relationship with suppliers, personal and invoicing data and telephone and e-mail addresses are acquired and processed.

### **3. PROCESSING PURPOSES:**

The aforementioned data IS processed for management of the contractual and pre-contractual relationship and, in particular:

- A. for execution of the contractual relationship with the data subject and fulfilment of the consequent legal (administrative, fiscal, accounting, etc.) obligations;
- B. for the management of pre-contractual negotiations;
- C. with the consent of the data subject, for marketing operations, by sending promotional communications and commercial information to the data subject.

### **4. DATA RETENTION PERIOD**

The data will be retained for the time necessary for execution/management of the relationship with the Supplier according to current provisions and, for marketing purposes only, for a period of 24 months.

### **5. NATURE OF DATA PROVISION**

The provision of data is optional but the refusal to provide certain data may make it impossible to perform the services relating to the relationship. Consent for marketing purposes (point C.) is optional and in any case may be withheld without this entailing any burden or damage on the part of the data subject in relation to his/her position vis-a-vis the Controller with regard to the purposes set forth in points A. and B.

### **6. PROCESSING METHODS**

The data is processed in compliance with the technical and organisational security measures provided for in the EU Regulation through appropriate procedures to ensure its confidentiality. The data will not be processed through automated decision-making processes. All data provided is processed according to the principles of integrity, lawfulness and transparency, in both paper and electronic form, and protected by technical and organisational measures to ensure appropriate levels of security in accordance with Arts. 25 and 32 of the GDPR.

### **7. SCOPE OF DATA DISSEMINATION**

The data may be processed by authorised and specifically trained persons. In addition to the persons just mentioned, the data provided may be processed by third parties, appointed as data processors, to the extent that this is necessary for performance of the activities carried out by the same for the data controller and within the limits of the authorisation profiles identified for them. The data communicated will not be transferred to third countries or international organisations outside the EU.

### **8. RIGHTS OF DATA SUBJECTS**

At any time, data subjects may exercise the rights referred to in Articles 15 et seq. of European Regulation No. 679/2016 and precisely: the right to know whether their personal data is being processed and therefore to know its content and origin, to verify its accuracy or request its integration, erasure, restriction, updating, rectification, transformation into anonymous form or blocking, as well as the right in any case to object, for legitimate reasons, to its processing and to lodge a complaint with the Personal Data Protection Authority. Consent to processing for the purposes referred to in point C. may be withdrawn at any time, resulting in the interruption of the processing. These rights may be exercised vis-a-vis the Controller as identified above by sending an email to the email address of the controller indicated above.
